I hope everyone is enjoying a great start to the semester. It's apparent that exciting things are happening at SCC. I wanted to provide everyone with an update following last Thursday's meeting of the Presidential Search Committee. We had great attendance and engagement. There were a number of questions raised that contributed, in my opinion, to the betterment of the process and the committee will decide if we will meet one more time in late February prior to the final meeting of the committee scheduled for the week of March 23rd. As of this morning, 45 candidates have submitted credentials for the Committee's review and consideration. As a reminder, I have attached, again, the calendar for the process which we will continue to abide by. When the Committee meets during the week of March 23rd, it will be charged with vetting five candidates for the Board's consideration. Since the board has requested the Committee submit five names, we will actually provide six to ensure, should one decide to decline to pursue the process, we will still be able to conform to the Board's request. The committee will submit these candidates, unranked, to the Board and following that submission, Dr. Davis will conduct the necessary reference checks and then the formal interview process will begin, with the Board currently planning to select the President during its May 4th meeting.

I am very grateful for the Committee's service to the process and I will continue to update you as the process moves forward and if you have questions, please feel free to let me know.
