Agenda Items:

- **Call to Order**
 - The meeting was called to order at 10:02 a.m.
- **Approve Minutes of January**
 - Mindy R. first motion, Lindsay seconded
- **Items for Discussion**
 - **Operating Standard for Athletic Scholarships for Review and Discussion**
 - **Robbie** suggested adding a required GPA of 2.0.
 - **Kaylyn** recommended keeping the language as vague as possible, as NJCAA has varying eligibility requirements.
 - **Keyarra** referenced the SAP policy, noting that some aspects of good progress are not included.
 - **Mindy** discussed FAFSA, emphasizing that students must maintain good standing with the college and a GPA of 2.0 or higher.
 - **Jackie** reminded the group that the athletic award is separate from FAFSA.
 - **Mindy** asked Brandy about consumables, and Brandy confirmed that these items are purchased through the Athletic Department budget.
 - Both **NJCAA and FAFSA** have GPA requirements.
 - **John** addressed the Athletic Handbook and will collaborate with Jackie to update the existing manual, where requirements are already listed.

- **It was noted** that athletes must take 15+ credit hours in their first semester, with exceptions for transfer students and those who were dual credit students.
 - **This item has been tabled** and will be revisited next month.
 - **The Operating Standard for A3100.65**
 - Changes were made to the existing policy, and it is recommended that the revised version be moved forward to the Executive Council. **Mindy made the first motion, and Keyarra seconded.**
 - **The Operating Standard for A3100.20 (FERPA). Deleting and merging A3100.100, A3100.115, and A3100.120 and using the new number A3100.20.**
 - The committee decided to move the FERPA Operating Standard forward to the Executive Council, with a question regarding the inclusion of HR in the responsibility section. **Kaylyn made the first motion, and Keyarra seconded.**
 - **The Operating Standard for A3300.15 Adding, Dropping, Withdrawal From Courses**
 - Danielle merged several old policies into a revised version. **Keyarra** suggested that the **Return of Title IV** policy should possibly be included and linked to the operational standards. The committee decided to move the revised standard forward to the **Executive Council. Mindy made the first motion, and Kaylyn seconded.**
 - **Operating Standard Pell LEU A3200.xx**
 - The committee reviewed the operating standard regarding Pell Grant eligibility and the 600% Lifetime Eligibility Used (LEU) rule. Discussion focused on its impact on students and any necessary clarifications. **The item will be revisited as needed.**
 - **Operating Standard Order of Aid Disbursement A3200.xx**
 - The committee discussed the revised standard, with several questions raised regarding disbursement for students who are considered homeless. This **item has been tabled** and will be revisited once a determination is made.
- **New Business**

Mindy R. presented a binder containing new and updated policies for easy access, provided by the President's Office. However, she noted that these policies are also available online.
