James Walton - Educational Talent Search

- **Recruitment Initiatives:** ETS recruitment is now open across all our school districts. We are actively engaging with potential participants to expand our program's reach and impact.
- **Curriculum Planning:** ETS is in the process of planning this academic year's curriculum. Our focus is on enhancing educational experiences that are both innovative and effective for our students.



- **Technology Enhancements:** To further improve our STEM curriculum, ETS has invested in new technology, including the Sphero RVR robots, which will be instrumental in teaching students coding skills. Additionally, we are exploring the integration of VR headsets to enrich our STEM offerings further.
- **SAT Preparation Revamp:** We are revamping our SAT preparation program for juniors to make it more engaging and enjoyable. We will utilize GameShowPro 3 to create an interactive and fun learning environment.

Mindy Reach—Director of Enrollment Services

- Credit hours are slightly up and will have the final count after the tenth day.
- Dual credit is currently being entered, and all will be in by Friday.

Keyarra Blissett—Financial Aid and Veteran Affairs

- **Financial Aid Office:** Our office imported 120 ISIRs in July and 178 in August. We currently possess 20 pages of UNLIKED ISIRs. Advisors and other personnel aiding students in completing the admission application or the FAFSA must emphasize the necessity of students providing their SSN; UNLIKED ISIRs impose an additional burden on the Financial Aid office and the Registrar. Our office is diligently updating student aid accounts to reflect current credit hours accurately. This process is manual and time-consuming, with over 300 enrolled students requiring review and adjustment. The deadline for FISAP is October 1.



- **Awarding:** MAP Grant certification will commence shortly. Any student eligible for MAP but submitting their FAFSA after August 21 will be waitlisted due to MAP Suspension. SCC, Athletics, and Saints Foundation Scholarships/Waivers recipients without a FAFSA on file will not transmit. We have been changing the aid to pending and notifying the athletic advisor for the athletes.
- **Veterans:** Working on the Veteran's Fiscal Impact survey that is due in September.
- **Satisfactory Academic Progress:** The SAP Appeal committee met twice for the Fall 2024 Semester. The committee reviewed 35 applications. The SAP Appeal Committee Policy has been submitted to the Student Affairs Council and is awaiting feedback. A new SAP Appeal procedure has been proposed. We are still working out the details due to inaccuracies in the process and its calculations. Additionally, we are working on a proposal to justify the resources needed to assist in correcting this matter.

Jacqueline Smith—Executive Assistant to the VPSA

- Bernie's Place has been utilized 136 times since the beginning of the semester. Michael Deno has worked hard to create a Kiosk that will help track participation. The Saints Foundation has also committed to ensuring that Bernie's Place will be sustained.

Danielle Boyd—Registrar

- Danielle and Stephanie are working on keying in enrollment and dual credit applications.

John Sparks—Athletic Director

- **Fitness Center:** The Anna Fitness Center had a significant upgrade in exercise equipment for the Fall semester. With the addition of six new treadmills, one stair master machine, and three 65" TV, the students and community members will have a much-improved workout experience. The Main Campus also had some major upgrades. These upgrades included four treadmills, one elliptical, one cable crossover machine, and a set of dumbbells with a rack. In both centers, we were able to replace outdated, out-of-order machines and add some new pieces. We used a power rack and a flat



Olympic bench in the athletic weight room. All three centers were able to get something that they needed.

- **Athletics:** We had approximately 88 student-athletes on campus this Fall who attended the Athletic Orientation on 8/13/24. In our Pre-Season Orientation, we discussed expectations, challenges, and how to handle adversity as a student-athlete. Volleyball season starts on 8/24 at Vincennes University, with our first home game on 8/30/24 at 11 am. Baseball and softball will not start until 9/1 for their fall scrimmage, running through 10/15. Men's and Women's Basketball are in the process of conditioning and weight lifting and will not see any scrimmages until mid-October.
